Professional Objective: To utilize my abilities and experience as a clinical psychologist to evaluate patients and provide recommendations for treatment and provide consultation and psychotherapy as indicated.

Summary of Qualifications: 22 years of experience that includes consultation, psychotherapy, and forensic psychological examination combined with a Doctorate of Psychology in Clinical Psychology and advanced degrees in Marriage and Family Counseling and the Humanities to enable me to make an immediate contribution to the effectiveness of a clinic, treatment center, or community. As a psychotherapist, I use my ability to quickly develop rapport with patients to create a safe environment that reduces anxiety, potentiating treatment effectiveness. I am experienced in the treatment of Dual Disorders. Generally, I utilize a cognitive behavioral approach during treatment. In my private practice, I perform a range of forensic examinations, including consultative examinations for Social Security, Worker's Compensation, and the Regional Center. In addition, I provide psychotherapeutic treatment. I have experience working as a provider for a number of major health care service associations, including EAP, SAP assessment, and CID services. I have instructed students at the College of the Redwoods, Humboldt State University, Long Beach State University, University of Houston, and the Texas Department of Criminal Justice (Alvin Community College) in addictions and psychology.

Duties

- Administer and interpret various neuropsychological assessment instruments including measurements of cognitive functioning, memory, learning and personality for mental health clients in clinic and forensic settings. As a Consulting Forensic Examiner, provide expert witness testimony and consultation to court officials relative to an individual's competency to stand trial, criminal responsibility (legal insanity), or other forensic issues. Conduct a variety of psychodiagnostic examinations ordered by the courts to provide forensic assessment to evaluate other mental health conditions that could affect legal proceedings. Review psychological information relative to legal requirements for determination of competency to stand trial for an alleged illegal act, formulate opinion, and make diagnosis. Prepare written reports for the courts detailing psychological findings upon which conclusions and recommendations were based. Maintain current knowledge of laws and acts that affect the field of forensic psychology. Conduct examinations for Department of Rehabilitation for assistance in determination of eligibility and make recommendations regarding academic capabilities and occupational interest. Conduct examinations for the Regional Center to determine cognitive functioning and adaptive behavior skills for assistance in determination of eligibility, conduct examinations for Worker's Compensation and provide psychological counseling for injured workers.
- Perform psychotherapy or provide professional consultation for the more complex or difficult client assessments and/or mental health programs.
- Perform client intake and psychological evaluation of clients new to the service; obtain client histories and determine mental status and perform diagnoses.
- Provide on-going psychotherapy and necessary referrals for clients as needs dictate; provide psychotherapy to chronically mentally ill adults and children, brief therapy for clients experiencing situational-type problems.
